SUBJECT : **LGU NATIONAL TRAINING ON CULTURE-BASED  
GOVERNANCE AND PROGRAMMING**

The Philippine Culture Education Program (PCEP) of the National Commission for Culture and the Arts (NCCA) and the Office of the Provincial Governor of Camiguin, in partnership with the Department of the Interior and Local Government (DILG) Region 10, will be hosting the **LGU National Training on Culture-Based Governance and Programming on May 30 – June 1, 2015 at Camiguin Convention Center, Mambajao, Camiguin.**

The national training is designed for Executives and Legislators of the local government units to underscore the significant role of culture in achieving good governance in the local government sector.

In view of this, all Provincial Governors and City/Municipal Mayors are enjoined to attend the activity. They are also encouraged to allow their respective Vice Governors, Vice Mayors, Sanggunian Members and Tourism Officers to participate in the training. A maximum of two (2) participants per LGU are invited to attend the activity.

The said training is free of any registration fee. All participants will be provided with lunch, workshop kit, materials, and a certificate of participation. However, roundtrip transportation to and from Mambajao, Camiguin and other meals (dinner and snacks), and accommodations during their stay in the province will be shouldered by the participants. Travelling expenses may be authorized, chargeable against local funds, subject to the availability of funds duly appropriated for the purpose, to the usual accounting and auditing requirements and to all other pertinent laws, rules and regulations. Provided, that the
